ANTI-DOPING – Acknowledgment & Agreement

TO BE COMPLETED BY EACH PLAYER, COACH and MEDICAL STAFF OF ALL TEAMS

I, as a participant in the WFDF 2018 World Ultimate Club Championships hereby acknowledge and agree as follows:

As a member of COUNTRY & DIVISION & TEAM NAME: _____ and/or a participant in an event authorized or recognized The World Flying Disc Federation (WFDF), I hereby declare as follows:

1. I have received and had an opportunity to review the WFDF Anti-Doping Rules*.
2. I consent and agree to comply with and be bound by all of the provisions of the WFDF Anti-Doping Rules, including but not limited to, all amendments to the Anti-Doping Rules and all International Standards incorporated in the Anti-Doping Rules.
3. I acknowledge that I am bound by, and confirm that I shall comply with, all of the provisions of the WFDF Anti-Doping Rules (as amended from time to time), the World Anti-Doping Code (the “Code”) and the *International Standards* issued by the World Anti-Doping Agency, as amended from time to time, and published on WADA’s website.
4. I consent and agree to the creation of my profile in the WADA Doping Control Clearing House (“ADAMS”), as requested under the Code to which WFDF is a *Signatory*, and/or any other authorized *National Anti-Doping Organization’s* similar system for the sharing of information, and to the entry on my *Doping Control*, Whereabouts and Therapeutic Use Exemptions related data in such systems.
5. I acknowledge the authority of WFDF [and its member National Federations and/or *National Anti-Doping Organizations*] under the WFDF Anti-Doping Rules to enforce, to manage results under, and to impose sanctions in accordance with the WFDF Anti-Doping Rules.
6. I acknowledge and agree that any dispute arising out of a decision made pursuant to the WFDF Anti-Doping Rules, after exhaustion of the process expressly provided for in the WFDF Anti-Doping Rules, may be appealed exclusively as provided in Article [13] of the WFDF Anti-Doping Rules to an appellate body for final and binding arbitration, which in the case of *International-Level Athletes* is the Court of Arbitration for Sport (CAS).
7. I acknowledge and agree that the decisions of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.
8. I have read and understand this acknowledgement & Agreement.
